Footnotes:

- (1) The following fees will be assessed separately in addition to the per credit hour/flat/blocked rate fees listed above:
 - Technology Fee - per student per semester: \$150 Fall and Spring, \$20 Summer.
 - Student Health and Counseling (SHAC) Fee - per student per semester: Fall/Spring for students taking 4 credit hours or more \$107, Summer \$72 per student.
 - Athletics Fee - per student per semester: Fall/Spring for students taking 4 credit hours or more \$100, Summer \$67 per student.
- (2) ASUNM Fee of \$35 assessed to all undergraduate students in Fall, Spring and Summer semesters in addition to hourly rates. This fee will automatically increase \$5 every 3 years until it reaches \$50 (\$40 beginning Fall 2025, \$45 beginning Fall 2028, and \$50 beginning Fall 2031).
- (3) All hours above block rates are assessed per credit hour for tuition, fees and differentials.
- (4) In accordance with the residency policy approved by the HED, the non-resident portion of tuition is waived for:
 - (a) All Summer Session Students except Nursing.
 - (b) 1st and 2nd semester Grad Students enrolled for no more than 6 credit hours per semester.
 - (c) Members of an Indian nation, tribe, or pueblo located wholly or partially in NM, regardless of residency.
 - (d) See "HED Policy on New Mexico Residency Status for Tuition Purposes" for other provisions.
- (5) Undergraduate Tuition Differentials for the Anderson School of Management, the College of Arts and Sciences, and the School of Engineering will be assessed to students in Programs of those Schools as well as to pre-majors.
- (6) College of Education Curriculum Fee \$125.00 (one time - new admits).
- (7) Law School Curriculum Fee \$175.00 Summer \$250.00 Fall/Spring. Master in Studies of Law Program Curriculum Fee \$16.03 per credit hour, all terms.
- (8) GPSA Fee of \$25 assessed to all Graduate and Dissertation students in Fall and Spring semesters in addition to hourly rates.
- (9) Accelerated Online Programs - Additional tuition assessments will be applied based on the school/college/program. Please reference the additional tuition assessment rates in this document for information on the additional tuition assessments that may be applied.
- (10) Los Alamos will assess a \$10.00 per semester Technology Services fee.
- (11) Taos will assess a \$30.00 Student Success fee per student.
