**Footnotes:**

- (1) The following fees will be assessed separately in addition to the per credit hour/flat/blocked rate fees listed above:
  - Student Technology Fee \$150 per student in Fall and Spring semesters, \$20 per student Summer semester.
  - Student Health and Counseling (SHAC) Fee - per student per semester. Fall/Spring for students taking 4 credit hours or more \$151 per student.
  - Athletics Fee per student per semester. Fall/Spring for students taking 4 credit hours or more \$120.
- (2) ASUNM fee of \$35 assessed to all undergraduate students in Fall, Spring and Summer semesters in addition to hourly rates. This fee will automatically increase \$5 every 3 years until it reaches \$50 (\$40 beginning Fall 2025, \$45 beginning Fall 2028, and \$50 beginning Fall 2031).
- (3) GPSA fee \$40 per student in addition to hourly rates for Graduate, Pharm D, MD and Dissertation students Fall and Spring semesters in addition to hourly rates. The GPSA Fee will automatically increase every fall semester by \$2 until it reaches \$50. (\$40 beginning Fall 2024, \$42 beginning Fall 2026, \$44 beginning Fall 2026, \$46 beginning Fall 2027, \$48 beginning Fall 2028 and \$50 beginning Fall 2029).
- (4) In accordance with the residency policy approved by the HED, the non-resident portion of tuition is waived for:
  - (a) All Summer Session Students except Nursing.
  - (b) 1st and 2nd semester Grad Students enrolled for no more than 6 credit hours per semester.
  - (c) Members of an Indian nation, tribe, or pueblo located wholly or partially in NM, regardless of residency.
  - (d) See "HED Policy on New Mexico Residency Status for Tuition Purposes" for other provisions.
- (5) HSC Library & IT Resource Fee \$262.50 per student Fall and Spring semesters.
- (6) HSC Student Council Fee \$1 per student for Fall and Spring semesters.
- (7) Physician Assistant Curriculum Fee \$8,000 per student for Fall and Spring semesters.
- (8) Medical School Curriculum Fee \$1,350 per student for Fall and Spring semesters.
- (9) Medical School Disability Insurance Fee \$103.08 per student Fall semester only.
- (10) Medical School Virtual Histology Fee \$100 per student one time only for new admits Fall semester.
- (11) Health Sciences Needle Stick Insurance \$10 per student with clinical rotation Fall semester only.
- (12) Physical Therapy Fee \$363 per student Fall and Spring semesters.
- (13) PharmD curriculum is offered Fall (Jul-Dec) and Spring (Jan-Jun) semesters only.
- (14) Pharm D differential tuition is assessed per credit hour up to 12 hours for both residents and non-residents. A differential tuition rate of \$398.48 is being phased in starting with the cohort of PharmD students entering in Fall 2021 and for subsequent entering classes.
- (15) College of Population Health is phasing in the graduate tuition differential for new graduate students beginning in Fall 2021 and subsequent years.
- (16) RN to BSN Degree Completion Option - students will be charged a rate of \$362.16 per credit hour for College of Nursing required 30 credits regardless of their residency status. These students will not be charged the Nursing differential tuition or fees.
- (17) Accelerated Online Programs - Additional tuition assessments will be applied based on the school/college/program. Please reference the additional tuition assessment rates in this document for information on the additional tuition assessments that may be applied.
- (18) Occupational Therapy tuition differential is assessed to students in the Occupational Therapy doctoral program beginning Spring 2024.

**General notes:**

- Final tuition and fee rates may differ slightly from proposed rates presented at Budget Leadership Team meetings and Board of Regents meetings.
- Final rates are rounded to the next even penny to accommodate the even split of scholarships that pay at 50%.
- Facility fees are not covered by the Opportunity Scholarship.
