Footnotes:

- (1) The following fees will be assessed separately in addition to the per credit hour/flat/blocked rate fees listed above:
 - Technology Fee per student per semester Fall and Spring, \$180.
 - Student Health and Counseling (SHAC) Fee per student per semester: Fall and Spring for students taking 4 credit hours or more, \$151.
 - Athletics Fee per student per semester: Fall and Spring for students taking 4 credit hours or more.
 - Undergraduates \$165 beginning Fall 2025, \$225 beginning Fall 2026.
 - Graduates \$150 beginning Fall 2025, \$210 beginning Fall 2026.
- (2) ASUNM Fee of \$40 assessed to all undergraduate students in Fall, Spring and Summer semesters in addition to hourly rates.
 - The ASUNM fee will automatically increase \$5 every 3 years until it reaches \$50 (\$40 beginning Fall 2025, \$45 beginning Fall 2028, and \$50 beginning Fall 2031)
- (3) GPSA Fee of \$42 assessed to all graduate and dissertation students in Fall and Spring semesters in addition to hourly rates.
 - The GPSA Fee will automatically increase every fall semester by \$2 until it reaches \$50.
 - (\$42 beginning Fall 2025, \$44 beginning Fall 2026, \$46 beginning Fall 2027, \$48 beginning Fall 2028, and \$50 beginning Fall 2029)
- (4) Facility Fee this portion of facility fees is not covered by the Opportunity Scholarship
- (5) In accordance with the residency policy approved by the HED, the non-resident portion of tuition is waived for:
 - (a) All Summer Session Students except Nursing.
 - (b) 1st and 2nd semester Grad Students enrolled for no more than 6 credit hours per semester
 - (c) Members of an Indian nation, tribe, or pueblo located wholly or partially in NM, regardless of residency.
 - (d) See "HED Policy on New Mexico Residency Status for Tuition Purposes" for other provisions.
- (6) Undergraduate Tuition Differentials for the Anderson School of Management, the College of Arts and Sciences, and the School of Engineering will be assessed to students in programs of those Schools as well as to pre-majors.
- (7) Students admitted to ASM graduate programs prior to Fall 2023 will be charged under the 2022-2023 graduate ASM tuition plus differential rate structure until completion of their program. University-wide increases are applicable to tuition rates. Current fees are applicable.
- (8) The current GASM tuition rate is applicable to students newly admitted to ASM graduate programs beginning Fall 2023 or later.
- (9) All hours above block rates are assessed per credit hour for tuition, fees and differentials.
- (10) College of Education Curriculum Fee \$125.00 (one time new admits).
- (11) Law School Curriculum Fee \$175.00 Summer, \$250.00 Fall/Spring. Master in Studies of Law Program Curriculum Fee \$16.03 per credit hour, all terms.
- (12) Accelerated Online Programs additional tuition assessments will be applied based on the school/college/program.
 Please reference the additional tuition assessment rates in this document for information on the additional tuition assessments that may be applied.
 The technology fee will also be assessed to students in accelerated online programs.
- (13) EMBA rate in effect for the cohorts listed. Previous cohorts will continue to pay the applicable cohort rate.
- (14) Los Alamos will assess a \$10.00 per semester Technology Services fee.
- (15) Taos will assess a \$30.00 Student Success fee per student.
